IN CONSIDERATION of being permitted to participate in any way in the sport and activities of paintball and/or airsoft at R-14 Paintball, Range 14, Ft. Dix Annex, I acknowledge, appreciate, and agree that:

1. The risk of injury from the activity and equipment involved in paintball/airsoft is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist;
2. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of those persons released from liability below, and assume full responsibility for my participation; and,
3. I understand that the activities of paintball/airsoft are physically and mentally intense. I understand the rules of play and will comply with all the rules and regulations. If I observe any unusual or unnecessary hazard during my participation, I will bring such to the attention of the nearest official as soon as practical; and,
4. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless the owners and employees of the 87th FSS, their officers, officials, agents, subcontractors, and/or employees ("releasees"), with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releasees or otherwise, except that which is the result of gross negligence and/or wanton misconduct and,
5. I agree to abide by the Field Rules, all Safety Regulations and the Instructions of the Referees and Staff Members and understand that failure to follow said Rules, Regulations and Instructions may result in my ejection from the activities and possible removal from the premises without refund or recourse.

I HAVE READ THIS MEMBERSHIP AGREEMENT, RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANCIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.

I agree that any equipment that is lost, broken, stolen or damaged in any way (excluding normal wear and tear) while signed out in my name is my financial responsibility. I hereby agree that I will reimburse the 87th FSS the full retail cost of all damaged, lost, or stolen equipment. I will only use the equipment as intended. As part of the rental agreement I promise to use only paint which has been purchased at R-14 Paintball in all rented or personally owned equipment.
